### Quotations

1. Quotations are valid for 30 days unless otherwise stated, and are subject to confirmation on receipt of order.
2. Where prices are quoted for a specified order or tender and the final quantity is below that specified then we retain the right to invoice at a higher amount.

### Damage and or loss in transit

1. Claims for non-delivery, breakage in transit etc., must be made within 14 days of invoice date (UK) or from date of arrival at destination (Foreign).

### Inspection & Errors

1. Claims for short delivery must be made within 14 days of invoice date (UK) or from date of arrival at destination (Foreign).

### Amendments & cancellations

1. Amendments & cancellations can only be accepted with the prior consent of Schuco.

### Terms of Payment

1. Pre-payment, or Credit account upon application.
2. Credit accounts are strictly 30 days net.
3. We reserve the right to charge interest at the rate of 1.5% per month on overdue accounts.
4. **Minimum order value £50 net.** Smaller orders may be subject to a £10 small order handling charge – except for repairs and/or spare parts.
5. Goods remain the property of Schuco International (London) Ltd. until payment is received in full.
6. Distributer minimum order value is £100 net.

### Guarantee & limit of liability

1. All products are guaranteed for one year against faults arising from faulty workmanship or materials; this excludes accidental damage, misuse and fair wear & tear.
2. To obtain warranty service please return the complete product to Schuco International (London) Ltd with all shipping charges pre-paid. A written explanation of the claimed fault must accompany the goods.

### Returns
